INSTALLATION & SERVICE INFORMATION MOUNTING

Flojet's 2130 electric carbonator pump is a self-priming pump. If the pump is vertically mounted, the pump motor must be on top. This is to prevent water from entering the motor chamber in the event of a leak. If mounted horizontally, the pump head may be rotated in 90° increments to simplify plumbing. It is best to mount pump as close as possible to the carbonator tank. A back flow preventer or check valve should be installed in the pump discharge line or the inlet to the carbonator tank.

PLUMBING

For best performance, flexible hose is recommended instead of rigid piping at the pump. Plastic fittings are recommended to prevent damage to inlet or discharge ports. Metal fittings, if over tightened, may cause pump head to fracture.

A water regulator is recommended in the inlet line to control pressure to a MAXIMUM of 30 PSI (2 BAR). The regulator should be installed as far as possible from the pump or a MINIMUM of 36 inches (.9 m) of tubing. This allows for dampening of possible hydraulic "hammer".

To further reduce the possibility of hydraulic "hammer", it is recommended to install a PULSATION DAMPNER in the inlet water line.

The model 2130 (high pressure) carbonator pump is

designed to operate effectively at pressures up to 125 PSI (8.6 BAR) with a flow rate of .32 GPM (1.2 LPM). The model 2130 (low pressure) carbonator pump is designed to operate effectively at pressures up to 80 PSI (5.6 BAR) with a flow rate of .42 GPM (1.6 LPM). The pump is equipped with an integral bypass to protect against excessive pressure in the event of a system malfunction, causing the pump to operate against a closed discharge. In the event the pump does operate against a closed discharge, for an excessive amount of time, the thermally protected motor will shut down by itself if overheating occurs, and will start again when the pump motor has cooled to operating temperature.


ELECTRICAL


For 100, 115 and 230 volt AC pumps, connect black wire from motor to black power lead and connect white wire to white return lead. Next, connect the green (ground) wire to ground lead.

OPERATION


Allow pump to prime without back pressure at the outlet to avoid an air lock. Once pump has primed, it is ready for normal operation. Because there is no built-in pressure switch to turn off pump, a remote switch must be used to shut down pump when desired. Additionally, on initial start up the carbonator tank may need to be vented to reduce excessive pump-up pressure and fill time.

TROUBLE SHOOTING

Motor operates, but fails to prime:

- · Restricted intake or discharge line. Air leak in intake line.
- Punctured pump diaphragm.
- · Defective pump check valve.
- · Crack in pump housing.
- Debris in check valves.

Motor fails to turn on:

- · Pump or equipment not plugged in electrically.
- · Loose wiring connection.
- · Defective motor or rectifier.
- Frozen cam/bearing.
- · Faulty carbonator tank level switch.

Pump fails to turn off when carbonator tank is filled:

- · Faulty carbonator tank level switch.
- No carbonator tank level switch installed and/or connected to pump.

Low flow and pressure:

- · Air leak at pump intake.
- Accumulation of debris inside pump and plumbing.
- Worn pump bearing (excessive noise).
- Punctured pump diaphragm.
- Defective rectifier or motor.
- Insufficient voltage to pump.
- · Defective bypass.

LIMITED WARRANTY
