
INSTALLATION:

Valve may be installed in any position other than the coil down. Flow must be in the direction of the arrow stamped on the underside of the body. Pipe sizes are shown in Table 1.

1. ELECTRICAL CONNECTIONS:

Make sure that incoming power corresponds to the voltage stamped on the front plate of the solenoid coil. See Table 2 for electrical specifications.



3. FLUIDS:

Valves are intended for water, air, light oil, and other noncorrosive fluids. They should *not* be used for gasoline and other hazardous or explosive fluids. Maximum fluid temperature is 200° F (93.3°C). Ambient temperature shall not exceed 120°F (48.8°C).

4. SERVICING:

- A. Failure to open:
 - 1) No power or low voltage.
 - 2) Burnt out coil (usually due to wrong voltage).
 - 3) Pressure differential to high. (Check MOPD in Table 1)
 - 4) Plunger jammed by dirt or damaged steel tube.

B. Failure to close:

- 1) Coil still energized.
- 2) Valve installed backwards.
- 3) Dirt on valve seat.
- 4) Plunger jammed by dirt or damaged steel tube.

RETURNS:


